| PREREQUISITES (Who can apply) | <p>Citizens and permanent residents of Singapore who hold a long-term visas for business or work purposes in Malaysia.</p> <p>Singapore citizens and PRs who want to re-enter Malaysia for work.</p> <ul style="list-style-type: none"> • After entering Malaysia, the employee should work at least three (3) consecutive months in Malaysia before returning to Singapore for short term home leave and subsequently re-entering Malaysia again. • Travellers will bear the cost of COVID-19 test • For travel via land border crossings between Singapore and Malaysia only. |
| APPLICATION BEFORE DEPARTURE | <p>MyTravelPass: The employer can apply for MyTravelPass for the employee to re-enter Malaysia.</p> <p>The employer can apply on behalf of the employee, via MyTravelPass online (http://www.mtp.imi.gov.my/) application at least 10-working day before the date of departure from Singapore to re-enter Malaysia</p> <p>The employer needs to provide the following documents:</p> <ul style="list-style-type: none"> • Letter of appointment; and • Copy of passport |
| RETURNING TO COUNTRY OF WORK | <p><u>Returning to Malaysia</u></p> <ul style="list-style-type: none"> • Travellers will be subjected to health screening at the Point of Entry • Travellers will be subjected to a modified Home Surveillance Order (HSO) for 7 days • Travellers will undertake COVID-19 RTK Antibody test at the end of HSO and will be released from HSO if tested negative • Travellers must subscribe to MySejahtera mobile application |

IMPORTANT NOTE

1. APPLICATION FOR PERIODIC COMMUTING ARRANGEMENT (PCA) BY CITIZENS AND PERMANENT RESIDENTS OF MALAYSIA

- Citizens and permanent residents of Malaysia who hold a long-term visas for business or work purposes in Singapore who wish to apply for Periodic Commuting Arrangement (PCA), please refer to Singapore's SafeTravel website at www.safetravel.ica.gov.sg

2. REQUIREMENTS FOR MALAYSIAN WORKERS RETURNING FOR SHORT-TERM HOME LEAVE IN MALAYSIA

- Travellers must subscribe to MySejahtera mobile application
- Travellers will be subjected to post-arrival COVID-19 PCR test in Malaysia
- If tested negative, travelers will be exempted from the 14-day Home Surveillance Order

(HSO)
